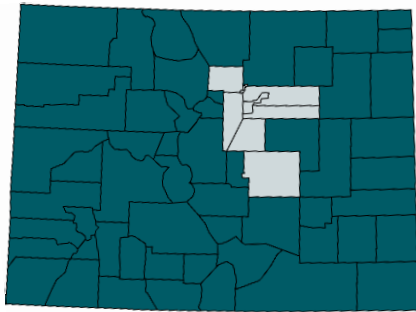

Introduction

Each year the Colorado Balance of State (BoS) Continuum of Care (CoC) conducts a Point-in-Time (PIT) study of the homeless population in Colorado's non-metro and rural counties. The PIT count has two major goals:

- Conducting an unduplicated count of individuals and families meeting the HUD definition of homelessness
- Capturing information about demographic characteristics and risk factors related to homelessness



The CO BoS CoC covers 56 counties across Colorado.

The Balance of State CoC covers the 56 non-metro and rural counties of Colorado. This includes all counties outside of metro Denver and Colorado Springs (El Paso County). This year the PIT count was held the night of January 29, 2019

PIT counts are required to be conducted at least biennially by the United States Department of Housing and Urban Development (HUD) as a condition of applying for HUD homeless assistance funds. PIT counts are important because they provide data to quantify the scope of homelessness and help national, state, and local policymakers track progress towards the goal of ending homelessness.

Methodology

During even numbered years, the CoC conducts a sheltered PIT count. During odd numbered years, the CoC conducts both a sheltered and unsheltered PIT count. In 2019 the CoC conducted a sheltered and unsheltered PIT count of individuals and families across the state. The PIT Count was conducted in accordance with the HUD methodology guide¹ and the HUD data collection notice² for the 2019 count. The survey instrument was developed by the Colorado Coalition for the Homeless (CCH), in consultation with their research partner, OMNI Institute.

For the **sheltered count**, the CoC counted all individuals and families “living in a supervised publicly or privately operated shelter designated to provide temporary living arrangements (including congregate shelters, transitional housing, and hotels and motels paid for by charitable organizations or by federal, state, or local government programs for low-income individuals)” on the night designated for the count.

For the **unsheltered count**, the CoC counted all individuals and families “with a primary nighttime residence that is a public or private place not designed for or ordinarily used as a regular sleeping

accommodations for human beings, including a car, park, abandoned building, bus or train station, airport, or camping ground” on the night designated for the count.

Regional PIT Coordinators throughout the state were responsible for planning and conducting the PIT count in their regions. CCH and the PIT Work Group provided training to all staff and volunteers, and Coordinators tailored additional trainings to meet their regions' specific needs. On January 29th service provider staff and volunteers administered the PIT survey forms to sheltered and unsheltered people experiencing homelessness throughout the Balance of State region. Nineteen counties participated in the 2019 PIT count.

Survey forms were collected and reviewed by CCH. OMNI Institute completed data entry of all the PIT survey data. The research team performed numerous checks to identify data entry errors, logic errors, and duplicate surveys. A total of 51 surveys were removed in the data cleaning process – 20 surveys were removed due to missing data, 8 surveys were removed because the HUD-defined homeless status could not be determined, and 23 surveys were identified as duplicates and removed.

Observational Data

In some instances, volunteers completed a visual count if they felt it was the best option not to disturb the individual or family. When completing an observational survey, volunteers were asked to complete the survey to the best of their ability and were instructed to write “OBS” in the space for both the first and last name to identify the survey as an observation. Observational surveys were not included in the overall count because of the increased probability of duplication in the count and because not all questions could be answered by observing an individual or family.

There were a total of 227 observed households with a total of 228 individuals in those households.

- 100% of observed individuals were staying in Pueblo County
- 100% of observed individuals were unsheltered
- Approximately 30% of observed individuals were female and 70% were male.
- Approximately 98% of observed individuals were 25 years old or older and 2% were youth.

Data Definitions

In order to create this report, we used HUD-provided definitions to create several variables during the cleaning process. Table 1 contains a list of all variables that were created and their HUD definitions.

Chronically homeless person	<p>A person who:</p> <ul style="list-style-type: none"> Is homeless and lives in a place not meant for human habitation, a safe haven, or in an emergency shelter; and Has been homeless and living or residing in a place not meant for human habitation, a safe haven, or in an emergency shelter continuously for at least 1 year or on at least four separate occasions in the last 3 years where the combined length of time homeless in those occasions is at least 12 months; and Has a disability.
Chronically homeless household	A household with at least one adult or minor head of household who is identified as chronically homeless. For households with more than one person, if one household member qualifies as chronically homeless, all members of that household should be counted as chronically homeless.

Interpreting PIT Data

The PIT count provides a snapshot of homelessness on a single night in January. Due to the transient nature of the population and the large geographic area of the Balance of State region, it is extremely difficult to capture all homeless individuals and families. Because of this, the 2019 PIT count should be considered an underrepresentation of homelessness in the Balance of State region.

The PIT survey relies on self-reporting, which may impact the data. Individuals may be unwilling to disclose certain information or may not realize that they meet the criteria for a specific condition. Many of the disabling conditions included on the PIT survey are stigmatized, which may lead to underreporting.

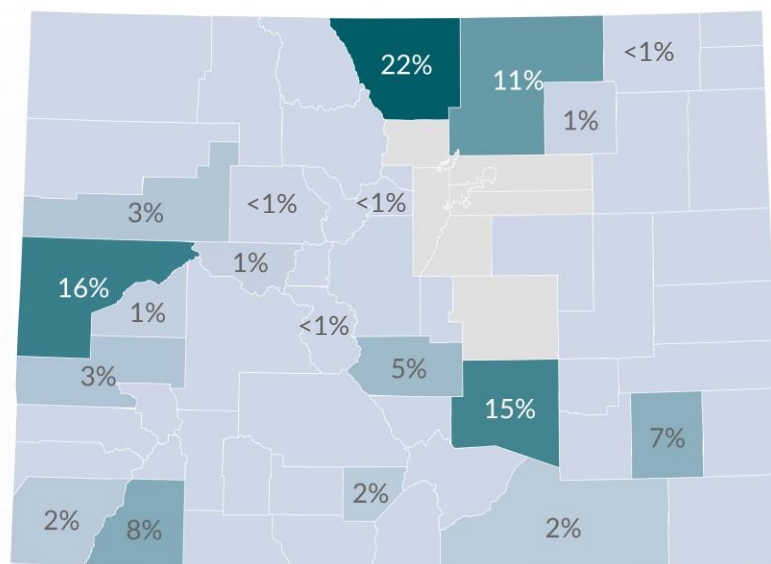
Finally, changes in the homeless population year to year cannot be solely determined by examining PIT data. Each year changes are made to the PIT methodology and survey forms. Additionally, local conditions such as the number of participating agencies, the number of volunteers, and unseasonably warm or cool weather can impact both the number of individuals who seek shelter and the number of individuals included in the PIT count. We recommend caution when comparing PIT count data over time. Increases or decreases in the homeless population may be due to methodology or changes in local conditions instead of true changes in homeless populations.

Snapshot of 2019 PIT Data

2,302 homeless men, women, and children in the Balance of State region in 2019

798 were **unsheltered**

This map shows where in Colorado the 2,302 people experiencing homelessness were living during the 2019 PIT Count. **The counties with the largest share of people experiencing homelessness were Larimer County (22%), Mesa County (16%), and Pueblo County (15%).**

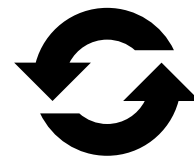

Findings

Across the Balance of State region, there were 2,302 homeless men, women, and children in 2019. Of these people, 798 were unsheltered and 1,504 were staying in emergency shelters and transitional housing programs. HUD groups individuals into one of three “household types” – households without children; households with at least one adult and one child; and households with only children. Children are defined as persons under 18. In 2019, the majority of households did not include children.

Demographics

This section provides information about the demographics of the homeless population and provides comparison data from the general population. The data for the general population came from the 2017 Colorado Census. For these comparisons, only the demographic categories that matched between the Census and the PIT survey are included.

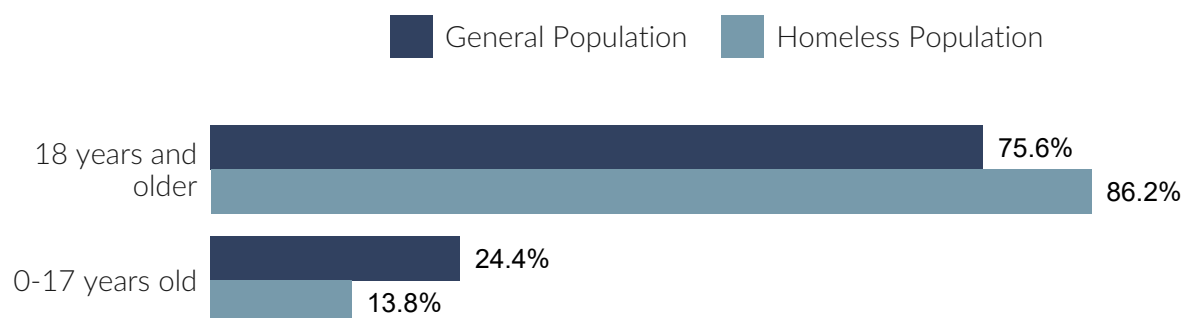
For the PIT survey, respondents reported the age range for each household member - adults (over age 25), youth (age 18-24) or children (under 18). Because exact ages were not reported, average age cannot be reported. The majority of individuals counted were adults over the age of 25. Less than a quarter of individuals were children under 18.

The following graph compares the percentage of people who were between 0 and 17 years old and those who were 18 years and older in the Census and PIT populations. Compared to the general population in Colorado, the homeless population was more likely to be someone who is 18 years and older.

FIGURE 1. AGE



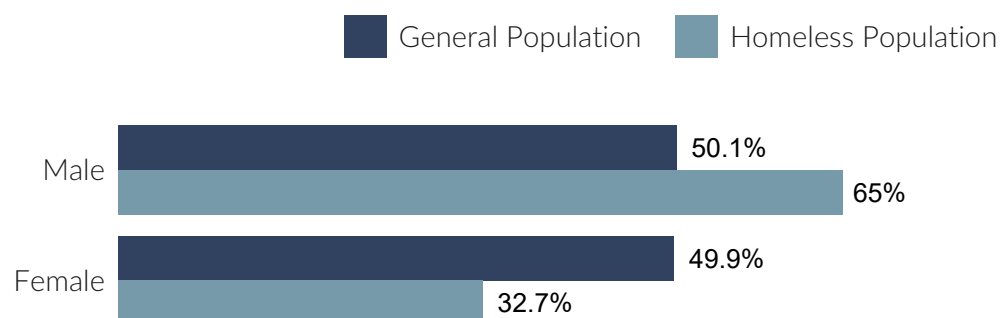
Male identified respondents outnumbered female identified respondents approximately two to one among the homeless persons counted. In addition, the percent of male identified respondents was higher among the homeless population than in the general population.

Approximately three-quarters of those counted reported their race as White and one quarter reported their ethnicity as Hispanic/Latino.

Compared to the general population in Colorado, the homeless population was more likely to identify their race as non-White. American Indian and Alaskan Natives make up 1.1% of the general population in Colorado, but represent 7.6% of the homeless population. Similarly, Black or African Americans, Native Hawaiian and Pacific Islanders, and individuals who identify as Hispanic make up a disproportionate share of the homeless population. Whites and Asians are underrepresented in the homeless population.

FIGURE 3. RACE

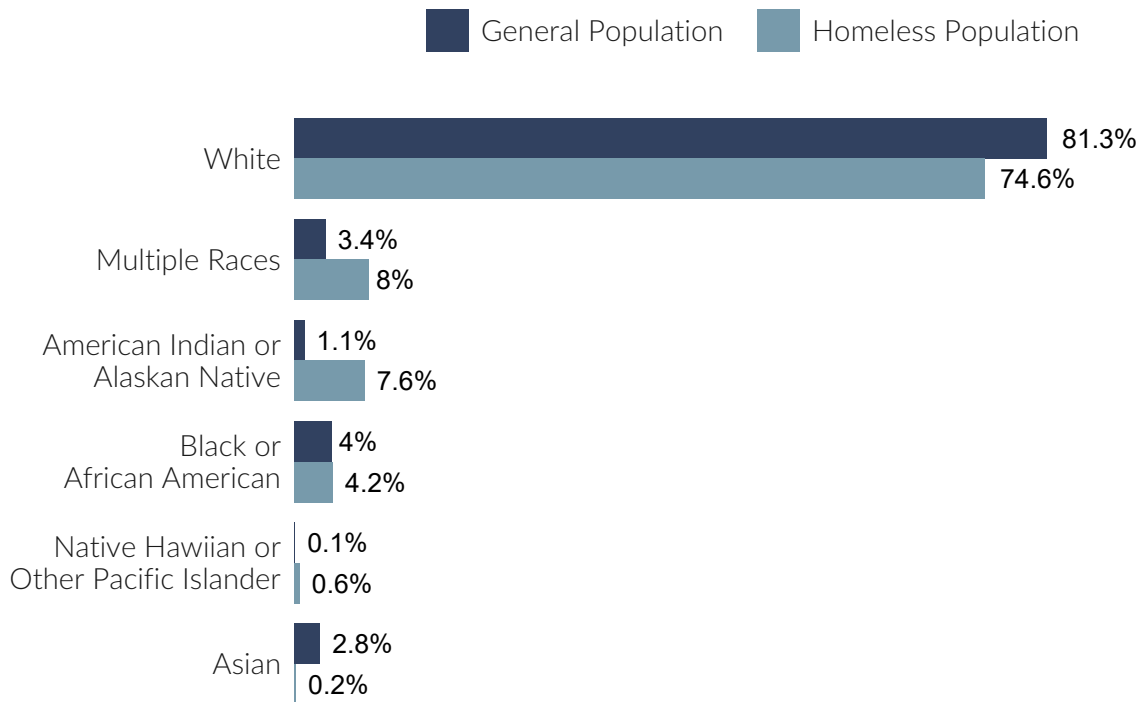
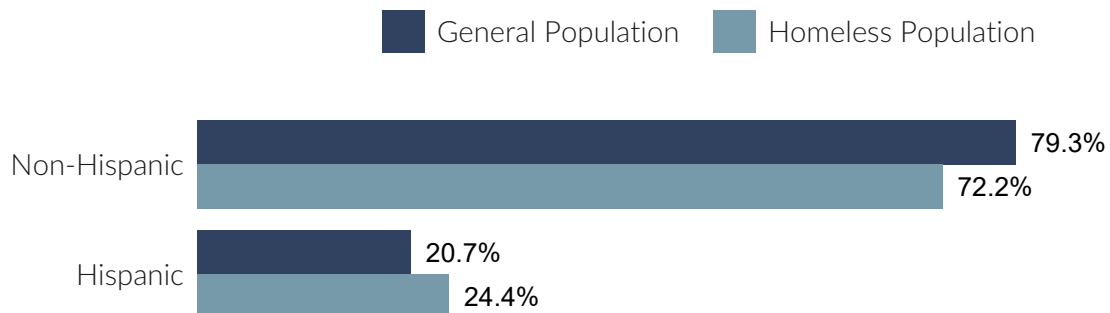


FIGURE 4. ETHNICITY



Risk Factors

For each household member, respondents were asked to report the presence of serious mental illness, developmental disability, substance abuse disorder, HIV/AIDS, PTSD, brain injury, or chronic physical illness or disability. Over half of homeless individuals had one or more disabling conditions. The most commonly reported disabling conditions were serious mental illness and substance abuse disorder.

Within the counted homeless population, there were several small but significant sub-populations. Approximately one out of seven individuals were currently fleeing domestic violence and about one in ten were veterans.

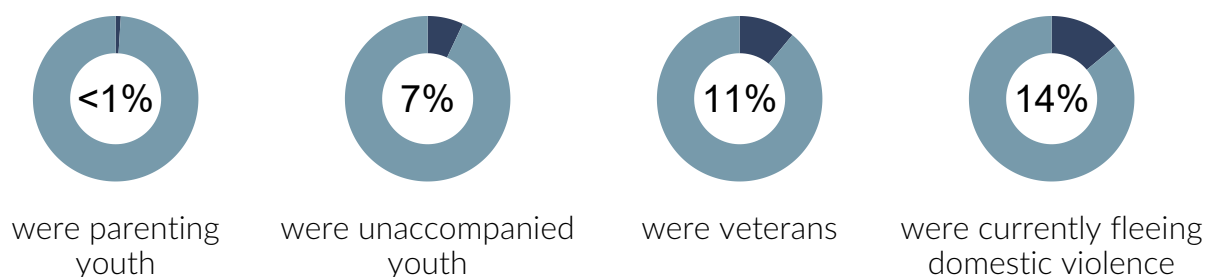

Approximately one out of three individuals were chronically homeless. The percentage of chronically homeless individuals among veterans was larger than the percentage across the entire counted population. Approximately two in five veterans were found to be chronically homeless.

Conclusion

The 2019 PIT count was success due to the hard work and dedication of staff and volunteers across Colorado. It is extremely difficult to gather Point-in-Time data due to the large geographic area of the Balance of State region and the transient nature of the homeless populations. The 2019 count should be considered a conservative estimate of homelessness in the Balance of State CoC.

The 2019 PIT count provides valuable information about the sheltered and unsheltered population. There are many takeaways from the data contained in this report including:

- 2,302 homeless men, women, and children
- 65% of homeless individuals were staying in emergency shelters or transitional housing
- 35% of homeless individuals were unsheltered
- 8% were families with children
- 22% were under the age of 25
- 56% reported at least one disabling condition
- 30% were chronically homeless
- 14% were currently fleeing domestic violence
- 11% were veterans

The 2019 PIT Report also highlighted racial and ethnic inequalities among those experiencing homelessness. Individuals who identify as American Indian/Alaskan Natives, Black or African American, Native Hawaiian/Pacific Islanders or Multiple Races make up a disproportionate share of the homeless population compared to the general population of Colorado. Individuals who identify as Hispanic are also overrepresented in the homeless population compared to the general population.

Additional data is included in the appendices. Appendix A includes information on household type, veteran status, individuals with one or more disabling conditions, chronic homelessness for each county and entitlement city. Appendix B provides a summary of the Point-in-Time data gathered for each county and entitlement city.

The 2019 Point-in-Time count provides required data for federal funding through the HUD Continuum of Care program. The data included in this report will be used by the Colorado Balance of State Continuum of Care and other stakeholders to inform additional outreach, service and program planning, and policy decision making as they work to address homelessness.
