# 2020 ANNUAL REPORT



The fear and uncertainty caused by a worldwide pandemic, stay-at-home orders, business closures causing income and job losses, and a nationwide economic downturn were big issues that affected us all.

#### For thousands of individuals and

**families,** 2020 was an emergency within an emergency. Those already experiencing homelessness faced fear and uncertainty, struggling to get basic needs met in harsh and dangerous environments. One can't "stay at home" unless one has a home, and more than 9,600 people in Colorado on a given night had no home.

#### Answering the challenge

The Colorado Coalition for the Homeless has been creating lasting solutions to homelessness for 36 years. In 2020, our focus remained true. As we worked to fulfill our mission with housing, healthcare, and supportive services, we rapidly expanded our capacity to serve even more people destabilized by the pandemic. Leveraging our strong collaborative partnerships in the government, business, and nonprofit sectors, the Coalition provided emergency housing and healthcare services to those experiencing homelessness and impacted by COVID-19.

The Coalition's expertise, flexibility, and capacity were critical to Denver's community-wide COVID-19 response and essential in keeping our entire community safe by addressing the critical needs of community members dealing with the impacts of homelessness.

The Colorado Coalition for the Homeless has long emphasized that having a safe, stable home is the essential first step in managing one's health. Without housing, health deteriorates. The stay-at-home orders issued in communities throughout the nation in response to the COVID-19 emergency underscored the essential connection between housing and health: staying at home protects you from a deadly virus.



As we worked to fulfill our mission with housing, healthcare, and supportive services, we rapidly expanded our capacity to serve even more people destabilized by the pandemic.

Households already contending with housing instability were further impacted by job layoffs and losses, swelling the numbers of people seeking help. Older individuals and those with underlying health conditions living on the street risked severe illness and even death as COVID-19 spread.

## New milestones reached in 2020



## 199 units of new supportive housing opened

We began the year celebrating the opening of 139 new apartment homes at **Fusion Studios,** our 20th residential property, hailed as a model of "...almost instant housing." The Coalition purchased a hotel, then refurbished and remodeled it to create permanent supportive housing for highly vulnerable adults, completing the renovation in only five months through a collaboration with the City and County of Denver, the State of Colorado, and private funders.

In 2020, we housed 93% more people in permanent and emergency housing than in 2019 David moved from the street into his home » at Fusion Studios just before the COVID-19 emergency began. 139 individuals gained permanent, stable homes with the help of the Coalition.

Many of the residents moved into their new homes after years living on the streets—most struggled with mental illness and other health conditions.

We completed construction of the **Renaissance Veterans Apartments at Fitzsimons** on Veterans Day, opening 60 new apartments for former service members. This project was the result of a partnership with the Coalition, the US Dept. of Veterans Affairs, the Colorado Dept. of Military and Veterans Affairs, the Colorado Department of Local Affairs, the City of Aurora, and private funders, creating a continuum of care, co-located with other veteran housing and services on the Fitzsimons campus in Aurora.

Fusion Studios and Renaissance Veterans Apartments at Fitzsimons increased the total number of supportive housing units owned and managed by the Coalition to more than 4,300.

Even before the appearance of COVID-19, the Coalition was addressing a significant gap in the types of housing needed to address homelessness. The Coalition designed the Stout Street Recuperative **Care Center**, a setting where people experiencing homelessness and high medical needs could convalesce after hospital stays, receive daily medical care, and connect with ongoing housing and supportive services. Four upper floors of this nine-story building-adjacent to our award-winning Stout Street Health Centercomprise the 98-unit **Renaissance Legacy** Lofts, a permanent supportive housing community. We finalized the financing and began the construction of this groundbreaking development in December.



### Housing IS Healthcare

The COVID-19 emergency created an unprecedented need and opportunity to implement housing and healthcare as part of the community-wide protection efforts. Coalition leadership worked with representatives of federal, state, and local agencies to secure funding for emergency housing to protect people recovering from COVID-19, and those at high risk of complications should they contract the virus. This collaborative effort secured funding to lease motels that had closed during the pandemic, creating 800 rooms of emergency housing. These units provided medical respite care for 2,400 patients recovering from COVID-19, and for 1,367 elderly individuals and others at high risk due to chronic health conditions.

Between April 1 and December 31, the Coalition provided COVID-19 emergency housing to more than 3,700 individuals and families experiencing homelessness. When added to permanent housing units owned and managed by the Coalition, the total number of households housed through Coalition efforts during the year was 7,967, a 93% increase over the previous year.

During the 2020 COVID-19 emergency, the Coalition provided emergency housing for an additional 3,767 individuals



## Meeting unique health needs during 2020

The Coalition is nationally recognized as a leader in providing integrated health services to those experiencing and at risk of homelessness. As the emergency evolved in Denver, the Coalition mobilized efforts to provide COVID-19 testing, primary care, housing, and specialized resources to prevent a catastrophic contagion among Denver's unhoused neighbors and those living in crowded emergency shelters. Telehealth encounters increased as **Integrated Health Services** providers reached out to those in encampments and provided behavioral health to those in housing and shelters.

We created integrated health clinics within the City's emergency 24-hour shelters at the National Western Stock Complex and the Denver Coliseum, providing COVID-19 testing and primary care to more than 1,000 shelter guests, many of them new patients to the Coalition's health services.



The Coalition served 15,494 patients with physical, mental, and dental care, and substance use treatment services.

### Resources for brighter futures

The Coalition works to honor the inherent dignity of the people we serve, affirming their capabilities and fostering their hope that a better life is possible. Supportive services like the Coalition's **Renaissance Children's Center** provided traumainformed childcare and early education that gave kids a safe place to spend the day when schools were closed, and provided a critical resource that allowed many parents to retain their jobs as essential workers.

#### Family Support Services staff served

an unprecedented 25% increase in new families reaching out for help, most experiencing housing instability for the first time due to the economic downturn. **Case managers** provided critical support to residents struggling with social isolation, substance use recovery, and mental illnesses during the stay-at-home orders.

An individual's hope—and their ability to build a better future—becomes a reality when the broader community recognizes the person as a neighbor in need rather than someone to be shunned and excluded. We saw this recognition reflected in the thousands of selfless ways that the community supported the Coalition's work.

### Community, working together

In this year of great challenge, we received the overwhelming trust and support of our community, volunteers, and donors. Despite the dangers of COVID-19 exposure, community members stepped up as drivers to deliver medications and supplies to those receiving care at hotel sites, freeing Coalition staff to focus on direct care and client services. Donors from all over the community helped to source face masks and other protective equipment for our workforce when supplies seemed almost impossible to locate and purchase. « People throughout the community donated supplies to help vulnerable residents stay at home and stay safe.

Charitable foundations came forward with desperately needed funding for direct services, supplies and equipment, emergency staffing, housing support, and even resources to promote emotional resilience for the Coalition staff. Individuals and businesses were generous with their financial gifts, supporting both emergency operations and ongoing programs responding to the dire conditions that people were facing.

Civic and business groups worked to gather resources for distribution to those experiencing homelessness. Volunteer groups throughout the region collected household items to create *Welcome Home* baskets for residents at Fusion Studios and gave funding and items to fully furnish and outfit the Renaissance Veterans Apartments at Fitzsimons.

## Looking ahead

As 2021 brings a reprieve from COVID-19 with vaccines becoming available, this pandemic has left 40% more people experiencing homelessness, and thousands more facing eviction.

More resources are needed to address the physical and behavioral health needs of those experiencing homelessness even as the COVID-19 pandemic subsides.

The Coalition remains committed to expanding homes, health, and hope to help people in their time of greatest need. We are deeply grateful for the trust and support of donors who have helped the Coalition work on the front lines this year and for your compassion toward Colorado's most vulnerable neighbors.

## Giving Back, Helping Others



## A Place to Recover

During the COVID-19 emergency, the Coalition's 800 hotel rooms served 3,767 individuals, providing a safe place for unhoused people to rest and recover, or to protect those who were at high risk of severe COVID-19 complications based on age and co-morbidities. By the end of the year, 139 patients were transitioned to permanent supportive housing.


