KEY DATES FOR 2025

**REGISTER TO VOTE ANY TIME UP UNTIL
AND INCLUDING ON ELECTION DAY!**

October 10 – First day ballots can be mailed to registered Colorado voters, except for military and overseas voters

October 20 – Mail ballots begin being counted and early in-person voting begins

October 27 – Last day to register to vote by mail, at a voter registration agency, a local driver's license examination facility, or online in order to receive a ballot by mail. Last day for voters to return their ballots through USPS to be counted. After this date, they will need to be dropped off

November 4 – Election Day! Voters must have submitted their ballot or be in line to vote in person by 7PM for ballots to be counted

COALITION BALLOT POSITIONS

SUPPORT



A support position indicates that CCH recommends a **yes** vote on the measure as approved by CCH's Board of Directors.

NO POSITION



No position means that CCH's Board has not approved a support or oppose position.

We recommend that voters do more research and where we can, we offer resources for you to learn more about all measures before deciding how to vote.

OPPOSE



An oppose position indicates that CCH recommends a no vote on the measure.

DENVER BALLOT MEASURES

This year's ballot includes eight (8) questions for Denver voters. Those denoted by the number 2 and a letter are referred to voters by Denver City Council, while those with only a numerical value are citizen initiated.

Measures 2A – 2E are known together as the **Vibrant Denver Bond**. The package includes improvements to roads and bridges, parks and recreation centers, libraries, museums and theaters, health care facilities, shelters, emergency response, and more across Denver. These projects would be funded through General Obligation Bonds, a common local financing tool used nationwide, and would not increase taxes. Denver uses General Obligation Bonds to improve public infrastructure every few years.

BALLOT ISSUE 2A (VIBRANT DENVER)



TRANSPORTATION AND MOBILITY INFRASTRUCTURE AND FACILITIES BOND:

Transportation and mobility infrastructure and facilities bond: repairs and improves roads, aging bridges, and busy intersections, making every trip – by foot, car, bike, or bus – safer and smoother.

BALLOT ISSUE 2B (VIBRANT DENVER)



CITY PARKS AND RECREATIONAL INFRASTRUCTURE AND FACILITIES BOND:

Upgrades and improves the parks, playgrounds, pools, and recreation centers where Denverites gather and get active.

BALLOT ISSUE 2C (VIBRANT DENVER)



HEALTH AND HUMAN SERVICES INFRASTRUCTURE AND FACILITIES BOND:

Delivers critical health clinics and support systems to improve care for Denver residents and families through projects including a new family health center in partnership with Denver Health.

DENVER MEASURES, CONT.

BALLOT ISSUE 2D (VIBRANT DENVER)



CITY INFRASTRUCTURE AND FACILITIES BOND:

Improves libraries, safety facilities, museums, theaters, botanic gardens, the zoo, and more for a vibrant and engaging Denver.

BALLOT ISSUE 2E (VIBRANT DENVER)



HOUSING AND SHELTER INFRASTRUCTURE AND FACILITIES BOND:

Improves access to safe, stable shelters and housing for those who need it through projects including ADA improvements at shelter facilities, new affordable housing developments across the city, and co-located affordable housing with a new library, ensuring more Denver residents have a safe, affordable place to call home.

REFERRED QUESTION 2F



RENAMING THE DEPARTMENT OF EXCISE AND LICENSING TO THE DEPARTMENT OF LICENSING AND CONSUMER PROTECTION

Renames the Department of Excise and Licenses to the Department of Licensing and Consumer Protection to make government agency services easier to understand.

REFERRED QUESTION 2G



CHANGING THE METHOD OF ELECTING AT-LARGE DENVER COUNCILMEMBERS

Change the way at-large members of the Denver City Council are elected, splitting at-large elections into two separate races: at-large A and at-large B. The winner of each race would earn a seat on council.

REFERENDUM 310



WHETHER TO RETAIN ORDINANCE 24-1765, PROHIBITING THE SALE OF FLAVORED TOBACCO PRODUCTS

Asks voters whether to retain the ban on the sale of flavored tobacco products passed by the City Council last December (official enforcement date set for January 1, 2026). A "yes" vote keeps the ban in place, meaning it would still be illegal to sell flavored tobacco in Denver. A "no" vote would repeal the ban, allowing sales.

STATEWIDE BALLOT MEASURES

The Colorado General Assembly passed House Bill 25-1274 during the 2025 regular legislative session, referring two measures to the ballot concerning tax revenue for the Healthy School Meals for All Program created through voter approval of Proposition FF in 2022.

PROPOSITION LL



ALLOW STATE TO RETAIN REVENUE FROM PROPOSITION FF MEASURE

Allow the state to retain and spend tax revenue collected above the \$100,727,820 annual estimate under Proposition FF for the Healthy School Meals for All Program. It would allow the program to continue offering free school meals for all public-school students through the 2025-2026 school year.

PROPOSITION MM



TAX DEDUCTIONS AND REVENUE FOR SCHOOL MEALS MEASURE

Lower the state tax deduction limits for taxpayers earning \$300,000 or more from \$12,000 to \$1,000 for single filers and from \$16,000 to \$2,000 for joint filers, generating \$95 million annually to support the Healthy School Meals for All Program. The General Assembly passed a Senate Bill 25B-003 during the 2025 special legislative session modifying the bill title to allow additional revenue to support the Supplemental Nutrition Assistance Program (SNAP) in addition to the Healthy School Meals for All Program.
